Register on the American Academy of Pediatrics' website. An account is free, and you don't need to be a pediatrician.







Video helps plan the transition to adult care

What does the future hold when your child becomes an adult? Pediatric providers are not the same as adult providers, so your youth's medical team will likely change.

It's best to have a plan in place to reduce anxiety and create a smooth transition. When youth are around 16 or 17, parents can start asking providers about this.

ORF2FHIC has created a five-minute, colorful video that shows the process and recommends questions. The video was written by students, parents, and doctors working together.
